Behavior Policy & Expectations

I hereby approve my child's application for membership to the Boys & Girls Club of Door County (BGCDC). I have received or viewed online a copy of the Club policies and procedures. I have read and explained the rules to my child and we agree to follow the Club rules and policies. We understand that Club membership is a privilege and may be suspended/cancelled at any time at the club's discretion.

Internet Usage

I hereby understand that my child may have supervised access to the Internet for web browsing and educational purposes. We do have restrictions on websites available to members. The BGCDC does not allow games with violence/guns to be played.

Viewing Movies

BGCDC has my permission to allow my child to view children's movies that are rated PG. These movies will be watched in advance by staff. (Examples would be: The Lorax, Up, How to Train Your Dragon.)

BGCA Data

I give my permission to the BGCDC to share information about the minor child listed on this application with the Boys & Girls Club of America (BGCA) for research purposes and/or to evaluate program effectiveness. Information that will be disclosed to BGCA may include the information provided on this membership application form, information provided by the minor child's school or school district, and other information collected by the Boys & Girls Club of Door County, including data collected via surveys or questionnaires. All information provided to BGCA will be kept confidential.

BGC Surveys

I give my permission to the BGCDC to survey my child about his or her Club experiences, risk behaviors, skills and attitudes. I give consent for my child to complete youth outcome surveys involving questions about his/her risk behaviors in the spring. I am aware blank sample copies of the youth outcome surveys will be available for review at the Front Desk. I agree that if I do not want my child to participate in the youth outcome surveys, I must provide notice in writing to BGCDC.

BGC Programing

I hereby give consent to BGDC to the participation of my child in all educational programs including but not limited to: SMARTGirls, Passport to Manhood, Smart Moves, Keystone Club, Project Learn/Power Hour, Youth-of-the-Year, Targeted Outreach, and The Arts Program. Special Permission will be requested for all off campus field trips. (Examples would be: Crossroads, business visits, etc.)

School District

I give my permission to the BGDC and my child’s school to exchange information regarding my child. Information that will be shared may include the information provided on this membership application form, school records involving student progress, behavior, attendance, and other information collected by the Boys & Girls Club of Door County, including data collected via surveys or questionnaires. Travel Policy

I authorize the BGDC to transport my child on field trips by bus or van within the local area during normal Club operating hours. No additional permission slip is required. (An example would be: Frozen Spoon).

Transportation between Club Sites

Grades 3+: Transportation will be provided for Southern Door students from Sawyer School to the David G. Hatch Center at 3:30p.m. via the Club vehicle.

Walks

BGDC has my permission to take my child on supervised walking trips (Nature Trail/Martin Park) with authorized staff members of the center. All precautions will be taken to ensure my child’s safety.

Media/Photo Permission

I hereby grant the BGDC the irrevocable right to photograph and record my child’s physical likeness and to use the said images in the production of promotional materials for the Boys & Girls Club. I relinquish all rights to copyright, title, property interest and/or any other interesting said photographs and I waive the right to inspection and approval of the finished reproduction.

Behavior Agreement
