Behavior Policy & Expectations

I hereby approve my child's application for summer membership to the Boys and Girls Club of Door County. I have received or viewed online a copy of the Club Rules and Policies. I have read and explained the rules to my child, and we agree to follow the Club Rules and Policies. We understand that Club membership is a privilege, and may be suspended or cancelled at any time at the Club's discretion.

Open Door Policy

I understand that Teen center members may check themselves in or out at any time. After checking in, members may check out and leave the Teen Center, but they may only check themselves back in ONE time.

Internet Usage

I hereby understand that my child may have supervised access to the Internet for web browsing and educational purposes.

Media/Photo Permission

I hereby grant the Boys and Girls Club of Door County Irrevocable right to photograph and record my child's physical likeness and to use the said images in the production of promotional materials for the Boys and Girls Club. I relinquish all rights to copyright, title, property interest and/or any other interesting said photographs and I waive the right to inspection and approval of the finished reproduction.

Administration of Medication

The Boys and Girls Club of Door County has my permission to administer over the counter and prescription medication when prescribed by a physician. I understand that the medicine must be labeled with my child's name, directions for administration, date, physician's name, prescription number and the name of the pharmacy.

Topical Products

The Boys and Girls Club of Door County has my permission to administer sunscreen, insect repellent or other products as needed to my child. (We will have sunscreen and bug spray for members to use at the Club. If you would like to send your own product, please label it with your child's name).

Viewing Movies

The Boys and Girls Club of Door County has my permission to allow my child to view children's movies that are rated PG-13. These movies will be pre-screened by a staff member. Ex: Harry Potter, X-Men, etc.

Walks

The Boys and Girls Club of Door County has my permission to take my child on supervised walking trips with authorized staff members. All precautions will be taken to insure my child's safety. We will be walking to the Door County Library and local parks on a regular basis, but may take advantage of additional opportunities should they arise.

Travel Policy

I authorize the Boys and Girls Club of Door County to transport my child on field trips by bus or van during normal Club operating hours. No additional permission slip is required.

Medical Emergency

I will not hold the Boys and Girls Club of Door County responsible in case of any injury resulting from my child's participation in Club programs. I give my permission for Club staff members to provide first aid treatment to my child. I also allow a physician or hospital to administer emergency treatment to my child or to be transported by emergency vehicles as deemed necessary.

Swimming & Park District Activities

I authorize my child to participate in swimming activities. All swimming will be supervised by a certified lifeguard.

I understand that it is my responsibility to inform the Boys and Girls Club of Door County in writing if my child cannot participate in any of the above activities.
